Order

In continue to the earlier order no. 19629-50/MA dated 09.09.2020 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no. SS/SCSH/2020/623 dated 19.09.2020. Now, I, Varinder Kumar Sharma, IAS, District Magistrate Ludhiana in exercise of powers conferred upon me under section 144 of CrPC 1973 order that the following activities would be permitted:-

1. On-line distance learning shall continue to be permitted and shall be encouraged. Schools, colleges, educational and coaching institutions will, however, continue to remain closed for students and regular classes.
2. 50% of the teaching and non-teaching staff shall be allowed to be called to the schools at a time for on line teaching/tele-counselling and related work in areas outside the containment zones only w.e.f 21.09.2020 as per SOP dated 08.09.2020 issued by Ministry of Health and Family Welfare (MoHFW), Government of India (GOI) in this regard.
3. Students of class 9 to 12 are permitted to visit their schools in areas outside the containment zones only, on voluntary basis for taking guidance from their teachers. This will be subject to written consent of their parents/guardians and will be permitted w.e.f 21.09.2020 as per SOP dated 08.09.2020 issued by Ministry of Health and Family Welfare (MoHFW), Government of India (GOI) in this regard.
4. Skill or entrepreneurship training are permitted in National Skill Training Institute, Industrial Training Institutes (ITIs), short term training centers registered with National Skill Development Corporation or State Skill Development Missions or other Ministries of Government of India or State Government.
Activities of National institute for Entrepreneurship and Small Business Development (NIESBUD). Indian Institute of Entrepreneurship (IIE) and their training providers are also allowed.
These will be permitted w.e.f 21.09.2020 2020 as per SOP dated 08.09.2020 issued by Ministry of Health and Family Welfare (MoHFW), Government of India (GOI) in this regard.
5. Higher Educational Institutions are allowed to open only for research Scholars (Ph.D) and Post graduate students of technical and professional programmers requiring laboratories/experimental works 2020 as per SOP dated 08.09.2020 issued by Ministry of Health and Family Welfare (MoHFW), Government of India (GOI) in this regard.
6. Open air theatres are permitted to open with social distancing and wearing of face masks/covers. However, cinema Halls, Swimming pools, entertainment parks, theatres and similar places will be remain closed.




